## DISCLAIMER ON NOTIFICATION FOR CHANGES IN FEES, CHARGES AND COMMISSIONS, AT THE END OF YEARLY EXPIRATION PERIODS

For any change on a fee, included in this form, that is less than the 1.2 times of the previous year's CPI (Consumer Price Index) an advance notification period of 30 days will be used before the change takes into effect. Customers will be notified with the necessary means of permanently recorded transmission including text messages, e-mailing and etc... Once taken into effect, a 15 day period is applied for remission of service upon request. Upon exercise of such right to remit the bank does not charge any extra fee and commission.

The Bank reserves the right to stop provision of services, if the customer does not accept the fee, charge or commission that is subject to a change. Continuation of usage of Bank's services mean acceptance of any changes relating to the fee change that is being notified.

In the case that the annual fee increase is higher than 1,2 times of the previous year's CPI a separate form for agreement on the fee change is required that accompanies the notification procedures. For on the spot and non-continuous transactions including money transfers, bill payments, checks and notes payments exclusions to these provisions may be applied depending on the channels that is utilized for realization of such transactions.

**TAXES AND FUNDS:** 5% BSMV (Banking and Insurance Transactions Tax) is collected over the charge, fee and commission amounts.

**COLLECTION METHOD:** In cash or through setoff or by registering debt to the account.

This tariff shall be valid until 31.12.2018 and in case that such fees are not changed until that date, validity period will be automatically extended to December 31st of the following year with the same conditions, until otherwise specified.
